How do electric vehicles get taxed in Spain?

To achieve this objective, a tariff tax (GA in Spanish) of 0% and a decrease of the specific consumption tax (ICE in Spanish) for electric and hybrid vehicles are established. Additionally, the National Electricity Company (ENDE) has a 90 days period to assemble the necessary structure to build the charging stations for electric vehicles.

What are the different types of electric vehicles?

ZEVs = zero-emissions vehicles, which include BEVs, PHEVs and fuel cell electric vehicles (FCEVs). NEV = new energy vehicle (China); includes BEVs, HEVs, PHEVs and FCEVs. LDV = light-duty vehicle (cars and vans). MDV = medium-duty vehicle. HDV = heavy-duty vehicle.
