

# Environmental protection standards for wind power and solar energy

What are the guidelines for offshore wind energy production?

As a result, eight guidelines and their policy implications are proposed, among them: (i) Establishment of a national offshore wind energy production target; (ii) Mapping of marine offshore wind zones; (iii) Adoption of a "one-stop-shop" procedure; (iv) Development of a guide for environmental licensing for offshore wind farms; and others.

What are UNFC solar and wind specifications?

"The UNFC solar and wind specifications are designed to classify solar and wind energy resources in a way that reflects the phases of their development projects while allowing comparison with other energy resources," said Frank Denelle, Chair of the EGRM Renewable Energy Working Group.

Do offshore wind projects need an environmental impact assessment?

Offshore wind projects mostly require an Environmental Impact Assessment for their installation. The one-stop-shop procedure for granting all licenses for offshore wind projects is a general trend. Strategic Environmental Assessment studies prevent severe adverse impacts on the marine environment.

What are ISO standards?

ISO standards in this area focus on maximizing efficiency and reliability of these technologies. They ensure that renewable energy systems are designed and operated to provide a stable, sustainable power supply while minimizing environmental impacts.
